1. Description of first aid measures

Inhalation: If product mist or spray causes respiratory irritation or distress, move the exposed person to fresh air immediately. 2. Most important symptoms and effects, both acute and delayed

Potential health symptoms and effects

Eyes: Causes eye irritation. Symptoms include redness, pain, tearing and swelling.

Skin: May cause skin irritation with redness, itching and discomfort. Prolonged and repeated exposure may cause drying and cracking of skin. **Inhalation:** Not expected to be a respiratory irritant under normal use. Inhalation of mist may cause irritation of upper respiratory tract.

Ingestion: Causes irritation of the gastrointestinal tract with nausea, vomiting, abdominal pain and diarrhea.

5.2 Special hazards arising from the substance or mixture

Closed containers may explode due to the buildup of pressure when exposed to extreme heat. During emergency conditions overexposure to decomposition products may cause a health hazard. 5.3 Advice for firefighters

8.2 Exposure controls


